

**TELUS COMMUNICATIONS INC. (FORMERLY BC TEL)**

**NOTICE TO ALL PERSONS WHO RECEIVED  
AL SERIES 11.35 % BOND  
REDEMPTION PROCEEDS ON  
DECEMBER 30, 1997**

IF YOU ARE A REGISTERED HOLDER OR PERSON WHO HAD BENEFICIAL OWNERSHIP OF AL SERIES 11.35% BC TEL BONDS and RECEIVED REDEMPTION PROCEEDS FOR THE BONDS ON OR ABOUT DECEMBER 30, 1997, THIS NOTICE WILL BE IMPORTANT TO YOU.

On May 8, 1998, the action bearing Court File No. 98-CV-147382 was commenced in the Ontario Superior Court by a representative group of Bondholders. On December 8, 2004, the Ontario Court of Appeal ruled that BC TEL breached the Trust Deed that governed the Bonds and that the redemption was wrongful.

On February 19, 2008 the Ontario Superior Court ruled that the beneficial owners of the Bonds were entitled to \$12.098 per every \$100 par of the Bonds in principal damages. McCarthy Tétrault LLP has acted as counsel to a class of persons who were beneficial owners of the Bonds. If you held the Bonds on December 30, 1997, you are a member of a class that is entitled to damages.

The amount of each Bondholder's principal entitlement will depend on how many Bonds were held at the time of the wrongful redemption on December 30, 1997.

**In order to claim compensation, you must file a Claim Form which must be post-marked on or before August 15, 2008, failing which, you will no longer be entitled to any compensation.**
