She is also a contributing author of the fifth edition of *Defending Class Actions in Canada*, published by LexisNexis.

Katherine is called to the bar in B.C. and Ontario and acts on disputes in both jurisdictions. She has appeared as counsel before all levels of court in Ontario and in the Supreme Court of British Columbia. Katherine has also represented clients in administrative proceedings before various statutory tribunals.
