A skilled advocate and trusted advisor, Adam helps clients achieve their objectives in complex disputes.

Adam's litigation practice encompasses trial and appellate advocacy in commercial cases, class actions, and public and administrative law matters, as well as in criminal and regulatory proceedings. He has acted as lead or co-counsel at all levels of court, including in more than a dozen appeals to the Supreme Court of Canada. He also advises corporations, non-profit organizations, and executives on their legal obligations in the political sector, including ethical compliance, conflicts of interest, election finance, political advertising, and lobbying law.

With experience in the legislative, executive, and judicial branches of government, Adam provides strategic counsel in high-stakes disputes and regulatory controversies, as well as on emerging public policy issues. He has been lead counsel in proceedings on Ontario's Commercial List and in significant constitutional litigation, both at first instance and on appeal. He has particular expertise in the law and policy surrounding Artificial Intelligence, and led McCarthy Tétrault's partnership with the Canadian Chamber of Commerce to develop the Canadian business community's position on the regulation of AI.

Early in his legal career, Adam was a law clerk to Chief Justice Beverley McLachlin at the Supreme Court of Canada, and to Justices James MacPherson, Janet Simmons, and Eleanore Cronk of the Court of Appeal for Ontario. He previously served as chief speechwriter to the Leader of the Opposition in the Parliament of Canada, and as a senior advisor to a Cabinet minister in the Government of Ontario. Adam has taught appellate practice and procedure as an Adjunct Professor of Law at the University of Toronto, and has lectured at law schools across Canada on constitutional and administrative law.

Adam's scholarship and commentary has appeared in the *Supreme Court Law Review*, the *Yale Journal of International Law*, and the *Michigan State International Law Review*, as well as in the *Globe and Mail*, *National Post*, *Toronto Star*, *Ottawa Citizen*, *Slate*, *Maclean's*, and *Policy Options*. He is the co-founder and a director of [Teach For Canada](#), a non-profit organization that works with northern First Nations communities to recruit, prepare, and support teachers. He was selected to be an Action Canada Fellow in 2010 and is a member (and former Chair) of Action Canada's Board of Directors. He was named a "Leader To Be Proud Of" by Start Proud, a national LGBTQ+ organization, in 2014, and was awarded the Meritorious Service Medal by the Governor General of Canada in 2017.

Born and raised in Vancouver, Adam received his law degree from Yale, where he was a Kirby Simon Human Rights Fellow. He holds an
