Gord's clients have included shippers on major pipelines and applicant pipeline companies seeking facilities and tolling approvals. He also has acted for Hydro One Networks Inc., Canada's largest transmission and distribution utilities, in respect of major rates revenue applications and facility expansion approvals.

Previously, Gord was in-house Senior Regulatory Counsel to one of Canada's largest pipeline utilities. His past experience also includes secondments as counsel to the National Energy Board.

Gord is a former Board Member of the Canadian Energy Law Foundation. He has been a speaker and panelist at the Canadian Petroleum Institute's International Program for Energy Sector Executives. He has also presented papers at the annual Canadian Energy Law Foundation Research Seminar on recent regulatory developments affecting the oil and gas industry, the emerging Canadian LNG industry, aboriginal issues, as well as other industry conferences on oil sands development approvals, arctic pipeline developments and regulatory issues facing shale gas developments in Quebec.
