- participated in the successful defence of a healthcare company in the first pharmaceutical product liability class action trial in Canada. In this recent decision, Plaintiffs were alleging that the healthcare company was responsible for psychiatric reactions experienced by the class members while taking an antibiotic. The action was dismissed, with the justice concluding that the Plaintiffs had not met their burden of demonstrating that the antibiotic was the cause of the psychiatric reactions;
- serving as lead partner pleading a case before the Superior Court in which the impact of not taking statins on the risk of sustaining a cardiac event was thoroughly analysed. The matter was dismissed by the Superior Court;
- She currently acts as the Lead partner in a massive class action relating to recovery by Québec patients of accessory fees charged by physicians in addition to the fees paid by the government to these physicians for medical care covered by the public Medicare system;
- She currently acts for a telecommunication company in two authorized class actions one for alleged misleading advertising and one for alleged breach to the *Consumer Protection Act*.

In addition to general litigation, Emmanuelle counsels large companies on their insurance portfolio and acts against Insurers in cases where coverage was denied. She also has an insurance recovery practice. As the former President of the Insurance and Civil Litigation section of the Canadian Bar Association, Québec Branch, she brings extensive policy knowledge, staying current on the latest insurance law changes by maintaining active involvement as a member of the executive committee.
