Steven is a partner in our Intellectual Property Litigation Group in Toronto. With a focus on patent litigation, he represents clients in the pharmaceutical, oil and gas, and telecommunications sectors. He appears frequently in the Federal Court and Federal Court of Appeal, primarily in patent disputes.

Steven is an adjunct professor at Osgoode Hall Law School where he teaches patent law.

As Co-Lead of McCarthy Tétrault's Oil and Gas Patent Litigation practice, Steven has been successful in significant oil and gas patent litigation mandates, including for Enbridge, Aux Sable, Preferred Sands, Clean Harbors, Astro Thermal Tec and Pulse Directional Technologies. The technologies at issue have included the steam-assisted gravity drainage ("SAGD") of bitumen, transportation of natural gas, downhole tools, waste cleanup and efficient heaters.

A selection of Steven's recent notable work includes:

- obtaining orders of prohibition preventing the launch of generic versions of Allergan's ophthalmic drugs COMBIGAN[®] and LUMIGAN RC[®];
- obtaining an injunction prohibiting launch of a generic version of Allergan's cosmetic drug LATISSE[®];
- successfully concluding infringement actions relating to generic versions of Allergan's ALPHAGAN[®] P (0.15%) and ASACOL 800[®] treatments;
- successfully concluding applications brought pursuant to the *PM(NOC) Regulations* relating to Allergan's BPH treatment RAPAFLOR[®];
- successfully invalidating key claims of JL Energy's patent relating to the transportation of natural gas by pipeline (*Aux Sable Liquid Products LP et al. v. JL Energy Transportation Inc.*);
- leading and co-leading judicial reviews for pharmaceutical clients, including Allergan and AbbVie Biotechnology in relation to LUMIGAN RC[®] and HUMIRA[®];
- successfully representing AbbVie Corp. and AbbVie Inc. in litigation regarding a treatment for Hepatitis C virus;
- successfully defending Bell Canada and TELUS communications against multiple patent infringement actions relating generally to IPTV (Internet Protocol television); and
