She has led litigation files in various fields, including consumer law, unfair competition, privacy, banking law, product liability, false or misleading advertising and in special remedies such as injunctions.

- Representing a telecommunications company before the Superior Court and the Court of Appeal in commercial cases alleging unfair competition;

- Defending an electricity supplier in an injunction relating to electric power transmission project;
- Representing a telecommunication company in an injunction relating to false or misleading advertising;

- Representing a U.S. financial institution in the context of Lehman Brothers' bankruptcy.
