Tracey Doyle is a lawyer in our Litigation Group in Toronto. Tracey's practice is centered on intellectual property matters including patent, trade-mark and copyright disputes. She has also advised clients regarding Patented Medicines Price Review Board issues and has represented clients in Patented Medicines (Notice of Compliance) proceedings.

Previous to joining McCarthy Tetrault, Tracey worked at a well-known intellectual property litigation boutique and in the intellectual property department of a large National firm. Tracey has appeared as counsel at the Federal Court and acted on behalf of large pharmaceutical companies.

While in law school Tracey was a research assistant for several professors, a teaching assistant for property law and an avid moot competitor. She won the first year law school moot, was a semi-finalist at the Harold G. Fox Intellectual Property Moot and won the Oxford International Intellectual Property Moot. During her articling term, Tracey was appointed an adjunct professor at the University of Ottawa law school and taught the intellectual property oral advocacy class.

Tracey received her JD in 2016 from the University of Ottawa. Tracey also completed her BSc at the University of Waterloo, her MSc in immunology and infection at McMaster University and her PhD in immunology and microbiology at the University of Ottawa. Tracey's PhD work focused on generating monoclonal antibodies against conserved regions of the influenza virus with an aim to contribute to developing a universal influenza vaccine. This research was conducted at Health Canada during the height of the H1N1 epidemic. She has authored and co-authored a number of scientific and legal publications.

Tracey was called to the bar in 2017. She is a member of the Law Society of Ontario, the Intellectual Property Institute of Canada, the Advocates' Society and the Canadian Bar Association.
