- Successfully acted as lead counsel to AbbVie in a patent infringement trial involving the drug HUMIRA®. The Court found AbbVie's patent to be valid and infringed and a remedies trial will be held to determine the quantum of damages. *AbbVie v. JAMP Pharma*, [2023 FC 1520](#)
